**Comments:** Meets requirements per the Centers for Medicaid and Medicare. All 50 states must follow the

Centers for Medicaid and Medicare (CMS) federal guidelines as outlined in rule §483.60 Food and Nutrition Services. While CMS recognizes the Certified Dietary Manager, Certified Food Protection Professional (CDM, CFPP) credential as one of the qualifications necessary to be a Director of Food and Nutrition Services, not all states have adopted state-level regulations related to such requirements. Curriculum at Stark State College will satisfy requirements for states that have adopted regulations that identify the Certified Dietary Manager (CDM) credential as a minimum requirement. Additionally, there may be other requirements to sit for licensure/certification such as work experience, background checks, etc. Facilities in states that have not adopted state regulations related to the CMS requirements must still adhere to CMS federal guidelines. Professional licensure/certification requirements vary state-to-state. Stark State College cannot guarantee that graduates of this program meet the criteria for all state boards. Students from outside the state of Ohio should contact the Board in their state of residence to understand regulations prior to enrolling in Stark State College's program.
