Comments: Curriculum at Stark State College will satisfy state requirements in the State of Ohio. The Physical

Therapist Assistant Program is fully accredited through the Commission on Accreditation in Physical Therapy Education (CAPTE). Students graduating from the Program will be eligible to apply to take the Physical Therapist Assistant National Physical Therapy Examination (PTA NPTE). The PTA NPTE is sponsored by the Federation of State Boards of Physical Therapy (FSBPT). A passing score on the PTA NPTE is recognized by the State of Ohio and all other states and territories listed on the FSBPT webpage <https://www.fsbpt.org/Free-Resources/Licensing-Authorities-Contact-Information>. The State of Ohio also requires the student to apply for licensure in the state, pass the Ohio Jurisprudence Assessment Examination, to submit and pass a background check, and to submit a Certificate of Education (COE). In the State of Ohio, the COE is completed by the institution from which the student graduates. Other states and territories may have different requirements. Stark State College cannot guarantee that graduates of the Physical Therapist Assistant Program meet the criteria for all state boards. Please refer to each state's or territory's licensure requirements as listed on the FSBPT webpage. In the State of Ohio, there are fees associated with the licensure application process and the exam processes.
